Handle increases in data volume and variety

Today's information has moved well beyond email and file data and now includes social media, IM, audio, video, and other types of structured content. But some of this data goes unmanaged, either because organizations are unprepared to properly handle it, or they choose to ignore the risk that this data presents. In many cases, information just can't be identified, or is unknown "dark data" that typically resides in disparate sources such as personal files, legacy systems, and data accumulated through merger and acquisition activity.

Without a way to proactively identify, manage, or enforce governance policies on this data, you're simply unable to defensibly retain and dispose of data for compliance—or accurately search and produce data in response to eDiscovery. The potential sanctions for non-compliance or spoliation can be significant from the courts and regulators. Compliance regulations will continue to escalate across many verticals in the future, and effective management of all information will be necessary to meet current and future obligations. Consider, for example, that the regulations enacted by Dodd-Frank now require some companies to retain all electronic communications related to an executed trade for periods up to 30 years or longer, and must make this data fully available to regulators within 24-72 hours.

In addition to stricter regulations, organizations also must contend with expanding data formats and massive data growth—two challenges that can significantly impact business productivity, efficiency, and costs.


Until fairly recently, you could accommodate the creation of higher data volumes with reasonable additions of hardware and storage.
